FULL POWER TELEVISION AUCTION NO. 64 WINNING BIDDER APPLICATIONS ACCEPTED FOR FILING

Pleading Cycle Established

The long-form applications (FCC Forms 301 or 301-DT) for the winning bidders in the Full Power Television Auction No. 64 listed in Attachment A have been found acceptable for filing. The Commission may return or dismiss any application if it is found, upon further examination, to be defective or not in conformance with the Commission's rules. In addition, applications listed in Attachment A that are pending with associated petitions for waiver are accepted conditioned on resolution of such requests.

Petitions to deny the applications listed in Attachment A must be filed no later than June 9, 2006 which is ten (10) days after the date of this Public Notice. *See* 47 C.F.R. §§ 1.4 and 73.5006(b). Oppositions to a petition to deny must be filed no later than five (5) days from the specified filing deadline for petitions to deny. Replies to the opposition must be filed no later than five (5) days from the filing date for oppositions. *See* 47 C.F.R. §§ 1.4 and 73.5006(c). All pleadings concerning these long-form applications should reference the specific file numbers of the individual applications.

An original and four copies of all pleadings must be filed with the Office of the Secretary, Federal Communications Commission, 445 Twelfth Street, S.W., Room TW-A325, Washington, DC 20554, in accordance with Section 1.51(c) of the Commission's rules. *See* 47 C.F.R. § 1.51(c). In addition, it is requested that a courtesy copy of all pleadings be sent to: Shaun Maher, Video Division, Media Bureau, Federal Communications Commission, 445 Twelfth Street, S.W., Room 2-A820, Washington, DC 20554.

The applications listed in Attachment A are available to the public for viewing on-line using the Commission's Consolidated Database System (CDBS) access to which is available through the Commission's web site: www.fcc.gov. Copies may be purchased from the Commission's duplicating contractor, Best Copy and Printing, Inc. ("BCPI"), 445 12th Street, SW, Room CY-B402, Washington, DC 20554, (800) 378-3160 or <http://www.bcpiweb.com>.

Upon resolution, favorable to the winning bidders, of matters raised in any petitions to deny and/or any other technical or legal issues raised by the long-form applications,¹ the Commission will issue a public notice announcing that it is prepared to award the construction permits to the winning bidders. *See* 47 C.F.R. § 73.5006(d). Within ten business days after the date of that public notice, the winning bidders will

¹ A winning bidder that is found unqualified to be a Commission licensee will be deemed to have defaulted, its application will be dismissed, and it will be liable for the payment specified in 47 C.F.R. §§ 1.2104(g)(2) or 1.2104(g)(3), whichever is applicable. *See also* 47 C.F.R. § 1.2109(c).

be required to make full payment of the balance of their winning bids. *See* 47 C.F.R. §§ 1.2109 and 73.5003. Broadcast construction permits will be granted only after the full and timely payment of the winning bids and any applicable late fees, in accordance with 47 C.F.R. § 1.2109(a).
